### RATE STRUCTURE

(Effective October 1, 2006)

#### PROBATE BONDS (*Administrator, Executor, Conservator, and Guardian*)

Amount of Bond	Rate (all rates based on per annum basis)
Up to \$15,972	\$100
\$15,972 - \$50,000	\$100 plus \$5.57 per \$1,000 over \$15,972
\$50,000 - \$200,000	\$290 plus \$4.45 per \$1,000 over \$50,000
\$200,000 - \$500,000	\$957 plus \$2.76 per \$1,000 over \$200,000
\$500,000 - \$1,000,000	\$1,784 plus \$1.12 per \$1,000 over \$500,000
\$1,000,000 and up	\$2,348 plus \$0.56 per \$1,000 over \$1,000,000

**NOTE:** all probate bonds are subject to a \$100 minimum annual premium.

#### COURT BONDS (*Appeal, Replevin, Injunction, and Attachment*)

Term Premium \$5.97 - \$22.18 per \$1,000 (depending on type of bond)

#### LOST INSTRUMENT BONDS

Term Premium \$5.97 - \$30.05 per \$1,000

Depending on the risk of the security that has been lost and whether or not the bond has a fixed or open penalty.

**NOTE:** All court and lost instrument bonds are subject to a \$100 minimum premium.
